



# INVESTIGATION SUMMARY REPORT

## PRIVATE RESIDENCE SHREVEPORT, LA.

# HISTORY

This home is wooden, and of pier and beam construction. The construction date is from the early 1930's and several rooms have been added since original construction, the dates of the additions unknown. Many of the residents of the neighborhood have lived here for years, and attest that this home has had a reputation for paranormal phenomena as far back as these memories serve. The current clients have lived in the home for approximately two years, with phenomena reported since the date of actual move in.

# EXPERIENCES

As the clients were moving in, as one of the teenagers was moving boxes up into the attic, she spotted a female form at the top of the stairs in the attic. The same teenager, the next day, saw the same female form along with a male, and a small child in the attic, the next day. This teenager was not aware of any previous sightings of this trio. The next door neighbor once lived in this home, and had several friends, without her consent, use a Ouija board in an attempt to summon spirits. This board, as it was used in the home, had previously been used in various graveyards in Shreveport, in an attempt to summon spirits. It is rumored that they had summoned or had otherwise seen a female form, a male form, and a small child in the attic after a session on the Ouija board, wearing clothing and with the general appearance as described by the teenager at a later time.

This same teenager saw a male form outside her bedroom window one morning, early. The male form was seen from the waist up, then vanished. The window is elevated, such that someone outside, not using a ladder or similar, could be seen only from the chin upward, and there is nothing readily or normally available in this location to stand on, looking into the window. The form also vanished, not consistent with stepping off a ladder or other elevated object. The current clients are storing the ashes of a cremated individual, in their home. This teenager, while looking at photographs at a later time, spotted an image, and identified it as the man seen outside her window. This was a photo of the cremated individual whose ashes are currently stored in the home. The viewing of these photos was casual, and not for the purposes of identifying the individual seen outside the window. It is also noted that the bedroom is a later addition to the home.

There are two additional rooms added, a bedroom on the back left, and a washroom. The back bedroom has a heavy oppressive atmosphere, and is noted for having cold spots, not explainable by air conditioning or heating failures. The washroom has a heavy atmosphere, and none of the clients' three dogs will stay or cross through this area unless forced to do so. None of the three dogs have any problems with any other area in the home.

The wife, female client, has had someone whisper into her ear, while working on the computer in the dining area, with no one visible to have done so. On the day of our investigation, 2 of the dinette chairs were moved around while the clients were gone, no one home at all to have moved these chairs. The night before, the husband spotted a form consistent with a small child, age 8 to 9, move down the

hallway. The husband was seated in a recliner in the master bedroom, with a clear view of the hallway. There is no one of this age in the family, and no one of that age visiting at the time.

All members of the household report regular, repeated drain of batteries in all areas of the home. This includes rechargeable batteries, such as in cell phones. When away from home, the batteries last for days. At home, even fully-charged batteries last less than one hour, even without use of the phone, etc.

# INVESTIGATION

DATE OF INVESTIGATION: January 27, 2012

PARTICIPANTS: BESS MAXWELL, KEITH MYERS, TRACI MYERS, JOHN COMBS

EQUIPMENT: Digital Cameras, Infrared cameras and DVR system, Digital audio recorders, Ion Counters, P-SB7 Spirit Box, Infra-sound detection equipment, Digital thermometers, Various EMF meters including Tri-Fields, Motion detectors including geophone and laser grid systems, Ovilus interactive voice communications device, and PEAR REG-1 units for the detection of anomalous human consciousness with software on Hewlett-Packard computers.

INVESTIGATION: At the time and places tested, no anomalous photos were taken. No data was noted on video. Nothing unusual was detected by laser grid or geophone. No high EMF fields from AC current were found in any location likely to result in prolonged exposure, although there are some areas of high EMF fields from older wiring. No anomalous hot spots or cold spots were noted. No anomalous motions were noted. No EVP voices were recorded. One recording was made of words formed by the P-SB7. No excessive positive ion counts were noted. No infrasound, nor standing waves of such, were detected at times of testing, in the areas of testing. No inordinate positive ion counts were noted.

## PERSONAL EXPERIENCES

Client T, Client A, Keith Myers – In the attic, several minutes into an EVP gathering session, Client T, standing with his hand wrapped around a 2 x 4 support beam, felt his hand touched and fully wrapped by an unseen hand, the impression being that of an adult hand, by size. A search of the area did not indicate a person that could have done this, or any natural object that could have caused this feeling.

Client A and Keith Myers – In the attic, at a later time than above, were gathering temperature data. The temperature was constantly and narrowly fluctuating. These fluctuations seemed to be normally within the range of 64.8 and 65 degrees, with no regular or constant readings. A request was made to drop the temperature down to exactly 63.2 degrees, such number being chosen as random. Immediately the temperature began a steady drop, stopping at exactly 63.2 degrees, and remaining constant and exact for approximately one minute, then resuming the normal 64.8 to 65.0 degree readings. These remained the norm for the duration of testing.

## PART TWO

### Consciousness Detection

This type of testing is passive in nature and designed to detect, through the quantum tunneling method, the probability that a human type consciousness may be present affecting the REG-1 units, when all incarnate consciousness has been removed from the areas of testing.. The minimum reporting standard for this type testing is  $p < .05$ , with  $p$  (probability) representing the chance that the event could be the result of chance alone in the probability distribution. Thus, the probability of an anomaly is 95% per test, or greater, to be considered statistically significant. We then compute the probability that all tests are false, that is, that none of the tests indicate an anomaly.

A total of 45 tests were run in all areas. At the minimum reporting standard of .05, we would expect to receive a total of 2.25 tests (3.0) due to chance alone affecting the probability distribution, resulting in 2.25 (3.0) false positives for the human consciousness being the cause. ( $45 \times .05 = 2.25$ ) The actual mean score for the 30 positive tests was  $p < .028926$ . The correction for the number of expected false positives would be  $19 \times .028926 = 1.30$  false positives, which we would round up to 2. As noted, we received 19 positives, much greater than the mathematically expected 2 if only chance were involved.

After the room designation, the number or alpha character designates the test number or sequence in that room, on that particular testing computer.

### The Ovilus

*Carl Jung, Swiss psychiatrist and the father of analytical psychiatry, coined the word “synchronicity”.*

*Synchronicity - The experience of two or more events, that are apparently causally unrelated or unlikely to occur together by chance, that are observed to occur together in a meaningful manner.*

*This concept does not question or compete with the notion of causality. Instead, it maintains that just as events may be grouped by cause, they may also be grouped together by meaning. Since meaning is a complex mental construction, subject to both conscious and unconscious influence, not every correlation in the grouping of events by meaning needs to have an explanation of cause and effect.*

**NOTE:** In the paranormal, there are many experiences which are noted and observed for which the laws of science, as we know and understand them at this time, cannot explain. In EVP studies, blank and sealed cassette tapes have been found to have EVP voices on them, without having been previously inserted into a recorder. The actual method of the sending of EVP voices remains unknown. Television sets, while turned off, have had faces of the deceased plainly visible, as if the set were on. Telephone calls with the caller having the voice and knowledge of a deceased individual have been heavily documented. Phone calls and text messages have been sent to cell phones which have no SIM card to properly receive calls, but do receive the anomalous calls. We simply do not know, at this time, exactly how these events occur or are possible.

In paranormal research, it is the reporting of these cases that is important. These and similar phenomena are reported by individuals who have never met or known each other, and live thousands of miles apart, and often hundreds of years. Yet the reports remain consistent. Case studies, in volume and over time, allow for hypotheses and theories. It is in this simple interests of reporting that this section is included.

The Ovilus is a device that intercepts EMF signals, and converts them to audio, from an internal dictionary of over 2,000 words. It is theorized that discarnate entities may be able to INFLUENCE, under some circumstances, this word selection process. It is not thought, in the majority, that these entities may exert 100% CONTROL over the word selection, and simple research and listening to the output of the device verifies this, to the normal and reasonable individual. It is also noted that coincidence may play a part in the process, with the probability of about 1 in 2,047, in getting a correct response to a direct question. It is only in the long term studies, with consistent reporting, that more exacting theories regarding coincidence versus influence may be formulated. Probability, from a math standpoint, rises sharply as valid answers are observed in larger quantity, over a brief period of time and small number of total responses. For example, the probability of getting two correct responses in a row is 1 in 4,190,209. ( $1/2047 \times 1/2047$ ) This assumes there is only one correct response per each individual question.

The manufacturer of the Ovilus device indicates at the present time, there is insufficient data, science, and case study to indicate the Ovilus data should be evidential. This author agrees. This case study is not presented as hard evidence. It is presented so that others may have and consider its merits, or lack thereof. If no reporting is made, no theories may be formulated, or comparisons made with other reports to study correlations, if any. Each person who reads Part

Three must consider this data in light of his own beliefs, or knowledge of events that are known to have occurred to them personally. Beauty here is truly in the eye of the beholder, or its lack thereof.

**CLOSING NOTES – PART THREE**

**There may have been additional incidents, or not. We have presented these incidents in Part Three in the interests of research and completeness of studies performed. It is acknowledged that answers may, in many cases, rely on judgment as to the accuracy of the answer. If the question, “Is the car red?” is posed, assuming the car’s color is not a transition color, the answer of either “yes” or “no” may be easily evaluated. Or, assuming no transition color, the answer to “What color is the car?”, the answer “red” may be easily evaluated. Others are not so simple, “Happy”, for example. And it is readily acknowledged that those hearing a response from an Ovilus device may NOT have sufficient knowledge to correlate a given answer as relevant or “correct”. The volume of comments received from the Ovilus device was very large, and there may be meanings that those of us not experiencing daily life at this home, or intimately familiar with its history, do not have a connotation for. The list is presented as received, in proper order, in the interest of completeness of research conducted. It is also noted that, although the words are spoken individually, there may be meanings or connotations in word groupings within word lists. These meanings or connotations may only be meaningful to certain individuals with the experiences to which these word phrases pertain, and not to all individuals. Words within the list that have an inordinate statistical frequency of appearance may also fall within the meaningful category, and need to be analyzed by those with a more intimate knowledge of the history of the location.**

### **THE MODEL P-SB7 SPIRIT BOX**

**This device utilizes a milli-second adjustable forward or reverse sweep technique coupled with a white noise distribution between frequency steps. This is designed to add ambient sound energy for the production of real time EVP, allowing for instant feedback in communications attempts. See item 16 in “General Parameters of the EVP Phenomenon”.**

An audio session was conducted in bedroom number four, an area where activity has consistently been detected. The model P-SB7 clearly spoke “Hello!”, and this is followed by Bess Maxwell repeating, “Hello.”, and “Did you hear 'hello'?”.

# CONCLUSION

At the time and places tested, no anomalous photos were taken. No data was noted on video. Nothing unusual was detected by laser grid or geophone. No high EMF fields from AC current were found in any location likely to result in prolonged exposure, although there are some areas of high EMF fields from older wiring. No anomalous hot spots or cold spots were noted, but a request to drop the temperature to a specific level was noted. No anomalous motions were noted. No EVP voices were recorded. One recording was made of words formed by the P-SB7. No excessive positive ion counts were noted. No infrasound, nor standing waves of such, were detected at times of testing, in the areas of testing. The consciousness testing was strong, and consistent in many areas. We feel that the personal experiences, and the positive tests received in the PEAR testing are probably indicative of an anomalous presence or presences.
